NO PARKING ORDINANCE

A. There shall be no parking permitted:

- 1. Within an intersection or on any sidewalk in New Boston.
- 2. On any public way in New Boston when it is practicable to stop or park such vehicle off the main-traveled part of said way, but in every event an unobstructed width of the way opposite a standing vehicle shall be left for the free passage of other vehicles and clear view of such stopped vehicles shall be available from a distance of two hundred (200) feet in each direction so as not to impede the normal flow of traffic or obstruct vision of vehicles exiting roadways, driveways and/or parking lots.
- 3. Pursuant to NH RSA 265:69, II (b), within fifteen (15) feet of a cistern, (hydrant).
- 4. Pursuant to NH RSA 265:69, II (c), within twenty (20) feet of a crosswalk at an intersection.
- 5. Pursuant to NH RSA 265:69, III (b), at any place where official signs prohibit parking, example, in a posted fire lane.
- 6. In any parking space posted pursuant to NH RSA 265:69, I (j) designated for a person with a walking disability.
- 7. Pursuant to NH RSA 265:69, I (i), at any place where official signs prohibit stopping.
- 8. Pursuant to NH RSA 265:71, all vehicles shall be stopped or parked parallel to the curb or edge of the roadway in the direction of authorized traffic movement with its right hand wheels within 12 inches of the right

hand curb or edge of the roadway, except when otherwise provided by local ordinance.

- 9. There shall be no parking permitted at the following locations:
 - a) Route 13 beginning at the east end of the bridge by the Wason Building around and down Mill Street for a distance of three hundred (300) feet.

B. OVERNIGHT PARKING AT TOWN HALL PARKING LOT

- 1. No parking allowed between the hours of 11:00 PM and 7:00 AM. * (7 Meetinghouse Hill Road)
 - * Non-applicable for 'call' Fire Department members who have responded to an emergency call during these hours
- 2. Any person violating Section 1 hereof shall be subject to a penalty of \$20.00 for the first offense and \$40.00 for each offense thereafter and also may be subject to being towed.
- C. All violations of such parking restrictions and charges shall be deemed the responsibility of the registered owner of the vehicle.

D. Vehicle Exception

- 1. The parking limitations set forth in the ordinance shall not apply to the following vehicles:
 - a) Emergency equipped vehicles as defined in NH RSA 259:28
 - b) Vehicles that are loading or unloading merchandise or passengers.

E. Penalties

- 1. Whoever violates any provision of the ordinance shall be fined the following:
 - a) \$250.00 for parking in areas designated for persons with a walking disability.
 - b) \$10.00 for all other offenses

F. Increased Penalties

- 1. Whoever fails to pay the fine noted above within 7 days, shall pay an increased penalty as follows:
 - a) \$75.00 for Handicap Parking
 - b) \$25.00 for all other offenses

2. Failure to pay within fourteen (14) days, the matter will result in referral to the Goffstown District Court. The registered owner of a vehicle who is found guilty of a violation of this ordinance shall be guilty of a violation and shall, upon conviction, be punished by a fine not to exceed \$1,000.00.

H. Revised/Effective Date

1. This Ordinance shall become effective upon passage by the Select Board.
